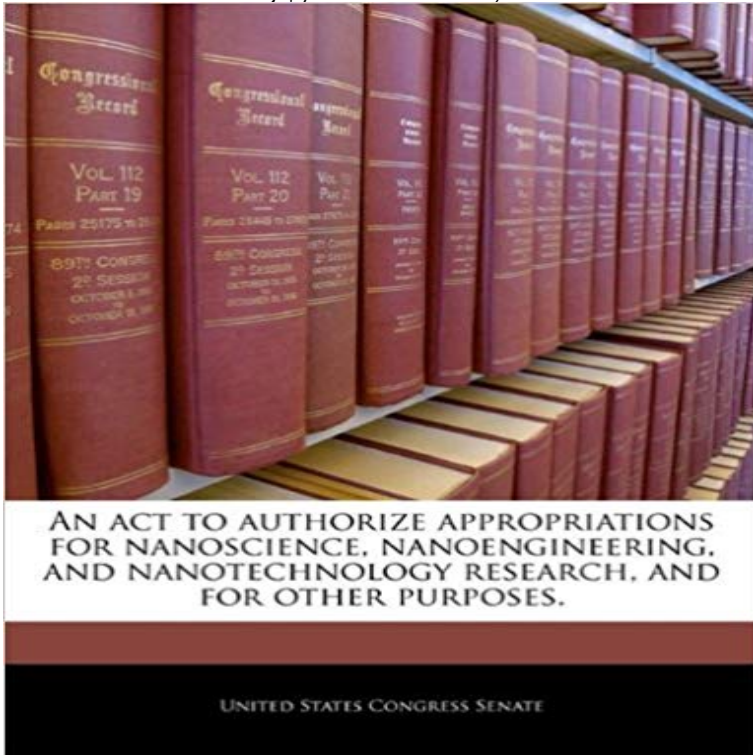


# An act to authorize appropriations for nanoscience, nanoengineering, and nanotechnology research, and for other purposes.
